INFORMATION TO CANDIDATES

1) Admissions: Applications are invited for admissions under Sponsored category into M.E./M.Tech./ M. Pharmacy courses for the academic year 2008-2009 offered at A.U. College of Engineering (A), and A.U. College of Pharmaceutical Sciences, Visakhapatnam.

- * Candidates who have already applied for PGE CET-2008 earlier should also apply. Applications received in response to this notification in the prescribed format will only be considered. The number of seats available in each course is 5.
- * Admission into the seats available under Sponsored category will be made as per the guidelines and eligibility criteria given in PGE C/PGE CET-2008 information booklet.
- * **Candidates with requisite qualifications and having a minimum of two years experience in Teaching / Industry / Research and Development as on 30th June, 2008 after acquiring the prescribed qualifications are only eligible to apply.**
- * The order of priority in selection for admissions under Sponsored category shall be (i) valid GATE Score (ii) Rank in PGE CET-2008 (iii) Marks obtained in the qualifying examination with a minimum of 60%. (iv) Sponsorship is essential for all candidates.
- * No other requests for admission will be entertained.

2) Employment: For all the programmes, candidates must be employed in the State of Andhra Pradesh.

3) Reservations: Reservation of SC/ST/BC categories will be as per rules. 33 1/3% of seats are reserved for women in all categories.

4) Separate application must be submitted for each discipline.

5) Candidates must fill in the course name, specialization and serial number as given in the P.G. programme sheet.

6) Hostel facility is limited for the selected candidates and no scholarship is offered by the University.

7) The following fees are payable:

(i) Registration fee of Rs.500/- to be paid in the form of crossed Demand Draft payable to "The Director, Directorate of admissions, Andhra University, Visakhapatnam" at the time of submitting the application.

(ii) Tuition fee for M.Tech. Programme Rs.25,000/- per semester.

(iii) Tuition fee for M.Pharmacy Programme Rs.50,000/- per semester.

8) Applications should be accompanied by the following:

- (i) Bank Demand Draft for Rs.500/- (separate application for each course applied)
- (ii) Attested copy of degree, date of birth, service and salary certificates
- (iii) Service certificate, No objection certificate and Sponsorship certificate from the employer in the prescribed proforma.

- (iv) Integrated permanent community certificate in case of SC/ST/BC in the prescribed proforma; from the Revenue Officer.
- (v) Attested copies of
- (a) Valid GATE Score card
 - (b) PGECET-2008 Hall-ticket and Rank Card
 - (c) Qualifying examination marks memos.
- 9) The applications duly filled in and complete in all respects together with necessary enclosures (documents) including Demand Draft should reach the "The Director, Directorate of admissions, Andhra University, Vijayanagar Palace, Pedawaltair, Visakhapatnam – 530 017 on or before 5:00 P.M., 13-10-2008. The candidates are advised to attend counselling as per the schedule given below. **No call letter will be sent in this regard.**
- 10) More number of candidates may attend the counseling than the number of seats available and mere attendance at the counseling does not guarantee allotment of a seat.
- 11) Applications received after the due date and incomplete in any respect will be summarily rejected. No correspondence will be entertained in this regard.
- 12) Registration fee will not be refunded under any circumstances. However in case of candidates who have already applied earlier to the Convener, PGECET-2008, the registration fee will be deducted from the course fee if valid proof is produced.
- 13) The University reserves the right to make alternations in the intake and rules for admission.
- 14) If it is detected that a candidate has been admitted due to any mistake made inadvertently in the processing of applications and during the admission stage, the University reserves the right to cancel the seat at any stage.
- 15) If any dispute concerning admissions into the courses offered at A.U. Colleges, Andhra University, Visakhapatnam arises, the jurisdiction shall remain with the Courts in Visakhapatnam and the High Court of Andhra Pradesh only.
